Requerimientos entrada inicial

Ciudadanos UE

- <3 meses: Pasaporte
- >3 meses: Registrarse GBA (Admon Municipal) al llegar y con el IND a los 3 meses

Ciudadanos otros Paises

- <3 meses: Pasaporte y visa (dependiendo del pais)
- >3 meses: MVV (visa especial para entrar a Holanda) y permiso de residencia

Proposito de Estadia

- Trabajo / Estudio
- Formar una familia / Visitar Familia
- Au Pair
- Tratamiento medico etc.

Requerimientos entrada inicial

Examen de Integracion Civica

- Se debe tomar en el pais de origen
- Valido por un ano
- No todas las personas necesitan tomarlo, depende del proposito de la estadia (ej: programa de intercambio, reunion familiar)

Permiso de Residencia

- Se envia aplicacion al IND
- 3 meses aproximadamente para responder
- High Skilled Migrants and Higher education students no deben hacerlo ya que la entidad realiza el proceso

Extension de Estadia

Extension Permiso de Residencia con igual Proposito de Estadia

- Solicitar extension antes de vencido (1 año la mayoría de las veces)
- “ Application for Renewal of a Residence Permit” (Solicitar al IND)

Extension Permiso de Residencia con diferente Proposito de Estadia

- “ Application for a Residence Permit without MVV or change to purpose of stay” (Solicitar al IND)
- Ej: Estudiante a empleado

Permiso de Residencia Independiente

- “Residence permit for continued residence”
- Varias circunstancias en la que esto aplica, ver www.ind.nl y Anexo #1

Permiso de Residencia Permanente

- Se puede aplicar si se ha vivido en Holanda por 5 años consecutivos con un permiso valido y de proposito no temporal de residencia
- “ Application for a permanent residence permit”

Extension de Estadia

Nacionalizacion (Obtener Pasaporte Holandes)

- Ser mayor de edad
- Haber vivido en Holanda, las Antillas Holandesas o Aruba por 5 años consecutivos con un permiso valido y de proposito no temporal de residencia. Los permisos de residencia se deben haber extendido a tiempo. Algunas excepciones aplican. Ver Anexo #2
- Estar completamente intengrado en la sociedad holandesa, ser capaz de leer, escribir y entender Holandes. Para esto hay que presentar el examen de integracion civica o haber sido eximido del mismo.
- No haber tenido problemas con la ley o haber tenido multas muy altas
- Estar preparado a renunciar a su actual nacionalidad. (Hay excepciones a esta regla)

Anexo #1

Residence permit for continued residence

If you are currently staying in the Netherlands with a temporary residence permit you **may be** entitled to a residence permit for continued residence. This is possible if you are in one of the following situations:

- You are married or have a registered partnership and have stayed with your spouse/partner for 3 years or more **Please note!** *In addition to the other requirements you must, since 1 January 2010, also prove that you have fulfilled the integration requirement or have been excused or exempted*
- You are married or have a registered partnership and your spouse/partner has died
- You are married or have a registered partnership and there are compelling reasons of a humanitarian nature
- You are a minor and have had a residence permit for a minimum of 1 year allowing you to stay with your parent or (adoptive) foster parent
- You are a minor and your parent or (adoptive) foster parent has died
- You are of age and have stayed with your parent for 3 years or more **Please note!** *In addition to the other requirements you must, since 1 January 2010, also prove that you have fulfilled the integration requirement or have been excused or exempted*
- You are of age and your parent has died **Please note!** *In addition to the other requirements you must, since 1 January 2010, also prove that you have fulfilled the integration requirement or have been excused or exempted*
- You are the victim of domestic violence
- You are a parent and have stayed with your child for 3 years or more **Please note!** *In addition to the other requirements you must, since 1 January 2010, also prove that you have fulfilled the integration requirement or have been excused or exempted*
- You have held a residence permit as a solitary underage foreign national for 3 years
- You have held a residence permit for 3 years because you are unable to leave the Netherlands through circumstances outside your control
- You have held a residence permit for medical treatment for 3 years and further treatment will be essential for at least 1 more year in the Netherlands
- You are a victim of human trafficking
- You are a witness reporting human trafficking

Anexo #2

5-year term

When does the 5-year term not apply?

- **During your adulthood you were adopted in the Netherlands, the Netherlands Antilles or Aruba by parents at least one of whom holds Dutch citizenship.**
- **You are married to or are the registered partner of a Dutch man or woman. If this is the case, you can submit an application for naturalisation after 3 years of marriage or registered partnership (possibly abroad) and uninterrupted cohabitation. If you have cohabited in the Netherlands with a Dutch man or woman (both partners unmarried) for an uninterrupted period of 3 years, you can also submit an application.**
- **The 5-year term is reduced to a 3-year term if you are stateless.**
- **The 5-year term is reduced to a 3-year term if as a minor you are acknowledged or legitimised by a Dutch citizen and have been cared for and brought up by this Dutch citizen for a period of 3 years.**
- **The 5-year term is reduced to a 2-year term if you have legally resided in the Netherlands, the Netherlands Antilles or Aruba for a period of 10 years, the last 2 of which uninterruptedly.**
- **You are a former Dutch citizen: you held Dutch citizenship in the past but have lost it. In some cases you will be able to use the option procedure.**
